REQUEST FOR QUOTE INSTRUCTIONS

The BIA invites the quoter to submit a firm-fixed price quote for the requirement: **Federally Chartered Corporations Training**. The NAICS is 611430 Professional and Management Development Training. The quoter shall submit 2 copies of the technical quote as a separate part of the total quotation package (not included with the price quotation). If e-mailed 1 copy is sufficient. The quoter shall organize the quote in two sections. Price shall be a separate document from the technical package.

Section 2 – Price Factor

- (1) Price Quote

The first page of the technical plan and the price quote shall each indicate the title: **Federally Chartered Corporations Training**

Font size for the quote shall be at least 12 point. Page margins shall be 1 inch, single column style. Quoters shall limit their responses to 15 pages or less including tables, graphics, appendices, resumes, cover letter, table of contents, *excluding* a signed copy of Offeror Representation and Certifications – Commercial Item The signed copy of 52.212-3 is only required if the contractor has not already completed annual certification at <http://orca.bpn.gov>.

1. Technical Factor

The quoter shall include the following in its quote:

a) Personnel Qualifications: The quoter shall describe their staffing approach and qualifications for personnel including any specialized expertise.

b) Past Performance: The quoter shall submit at least three past performance references for contracts entered into with Federal, state and local governments, Native American tribes and commercial businesses, which are of similar scope, magnitude, relevance, and complexity to the requirement which is described in the RFQ. If the quoter is not the prime for

the reference, this information must be clearly indicated as well as the prime's contact information. Include the following information for each contract:

(1) Name of contracting activity.

(2) Contract number.

(3) Contract title.

(4) Contract type.

(5) Brief description of contract or subcontract and relevance to this requirement.

(6) Total contract value.

(7) Period of performance.

(8) Contracting officer, telephone number, and E-mail address.

(9) Contracting Officer's Technical Representative, telephone number, and E-mail address.

1. **c) Technical Approach:** The quoter shall describe its Technical Approach and plan for accomplishing the work described in the Statement of Work (SOW). The plan shall include a proposed plan of the project design and proposed curriculum.

EVALUATION CRITERIA

Under FAR 12 and 13, the government intends to award a single firm-fixed price purchase order to the successful quoter whose quote conforms to the RFQ, is determined to be the best overall value to the government, price and other factors considered. The government will perform a trade-off analysis of non-price factors against price to determine the best value to the government. Quotes that are unrealistically low will not be considered for award due to the indication the quoter does not understand the complexity and risk to meet contract requirements. The government may award this purchase order based upon initial quotes received without discussions; therefore, the quoter is advised to submit their best approach. Evaluation criteria are listed in descending order of importance with 1 being significantly the most important.

1.) Personnel Qualifications: the minimum qualifications for personnel are:

- A. Trainer(s) must possess a Juris Doctorate degree from an accredited University.
- B. Expertise on sovereignty, regulation, taxation and economic policy as it relates to Indian Country
- C. Experience in conducting this type of training (or similar training) for Native American, government or private industry groups.

2.) Past Performance: Each reference will be evaluated:

- A. To determine the risk of non-performance, defective performance and late performance.

3.) Technical Approach: Demonstrated technical approach to meeting the project objectives and milestones as stated in the SOW.

- A. The completeness of the proposal should allow BIA to understand the methods to be used and how the contracting officer's representative (COR) and the customers are integrated into the plan.

4.) Price

- A. Price will not receive a weighted score rather it will be used to determine a successful quote.
- B. In the event the submissions become equal in technical merit, price becomes more important.

US Department of the Interior, Bureau of Indian Affairs ratings focus on the ability of the quoter to accomplish the goals outlined in the SOW as well as strengths, weaknesses and risks demonstrated in the quoter's technical plan. Ratings will be assigned to each technical quote by the reviewer(s) based on the criteria above. In the case of more than one reviewer, the ratings will be assigned by consensus.

Adjectival Rating	Description
Exceptional	Greatly exceeds all minimum requirements of the criteria; has a high probability of success; contains no weaknesses or deficiencies.

Good	Exceeds all the minimum requirements of the criteria; has an above average probability of success; contains no significant weaknesses and only minor, correctable weaknesses exist.
Acceptable	Meets all the minimum requirements of the criteria; has an average probability of success; no significant weaknesses and any deficiencies can be readily corrected.
Marginal	Fails to meet one or more of the minimum requirements of the criteria; low probability of success; major weaknesses and contains significant number of deficiencies exist.
Unacceptable	Fails to meet any of the minimum requirements of the criteria; proposal needs major revisions; very low probability of success. Statement of Work

Federally Chartered Corporations Training

Background

In passing the Indian Reorganization Act of 1934 (IRA), Congress intended to provide tribes with the ability to compete in the private business world. Section 17 of the IRA gives tribes the ability to incorporate and to waive sovereign immunity to facilitate business transaction. A Section 17 Corporation provides the framework by which a tribe can segregate tribal business assets and liabilities from the assets of liabilities of the tribal government. It also preserves the integrity of the decision-making process of tribal government officials by separating business decisions. The charter defines the powers of the corporation and provides the ability to conduct business operations. Tribal corporations formed under Section 17 have the same tax status as the tribe and are not subject to federal income taxes for income derived from on or off the reservation activities.

Tribally chartered corporations have been utilized with increasing frequency by tribal governments to conduct various types of economic development and business activities. Developing a Section 17 corporation could greatly enhance a tribes' ability to foster economic development and independence. As tribes have become more aware of the benefits of Section 17 corporations, they have requested assistance in understanding and developing Section 17 corporations. In order to address this current need, the Office of Indian Energy and Economic Development is looking to provide several tribes with training on the development of tribally chartered corporations.

Objectives

The primary objective is the development and presentation of a one full day training session, taught by individual(s) with expert knowledge and experience related to federally chartered corporations under Section 17 of the IRA. More specifically, the objectives are as follows:

1. Provide recipients with general background on the history and purpose IRA Section 17.
2. Provide recipients with descriptions and examples of tribally-chartered corporations.

3. Provide recipients with a full understanding of the advantages and disadvantages of establishing a Section 17 Corporation.
4. Provide recipients with an understanding of Sovereign immunity and liability issues as they relate to Section 17 corporations
5. Provide recipients with an understanding of tax issues, both state and federal, as they relate to Section 17 corporations.
6. Provide the recipient with information on legal issues (both state and federal) surrounding the establishment of tribally-chartered corporations.
7. Provide recipients with the legal steps required to formulate a tribally-chartered corporation.
8. Provide recipients with pertinent information on the relationship between a Section 17 corporation and the tribal government.
9. Provide recipients with a model/sample for a Section 17 corporation

Scope

The Office of Indian Energy and Economic Development will obtain training on aspects of Section 17 of the IRA. The Contractor shall provide training for up to 20 individuals at each of the 7 training locations identified below in the section entitled "Places of Performance".

Tasks

The contractor shall identify the tasks to be performed to achieve the objectives of the SOW.

Deliverables

Contractor Identification: When performing as contractor, the contractor shall identify themselves as contractors for the government both orally and in writing. In addition, all materials produced under contract must be labeled sufficiently to identify it as contractor produced materials. Under no circumstances shall the contractor state or imply that he or she is acting on behalf of the Government.

The contractor shall refrain from providing specific legal advice to trainees, especially tax advice, and shall make clear it that the development of charters and the management of corporations require the advice of hired legal counsel. The purpose of the contract is to give the trainees an overview that will enable them to work more effectively with their legal counsel.

1. **DRAFT COURSE OUTLINE:** Provide COR an electronic draft course outline of the proposed final schedule that describes the method of instruction (i.e. case study, group discussion, breakout sessions etc.) for each section. The COR will review the draft proposed final curriculum, measure it against the SOW objectives, tasks, and deliverable acceptance criteria and, if acceptable, authorize the contractor to proceed. The COR will respond within 5 business days.
2. **DRAFT TRAINING MATERIALS:** Provide COR an electronic draft of the training materials to be provided at each session. The COR will review the draft proposed final training materials, measure it against the SOW objectives, tasks, and deliverable acceptance criteria and, if acceptable, authorize the contractor to proceed. The COR will respond within 5 business days.
3. **TRAINING MATERIALS:** Develop a binder of approved training materials to accommodate 140 attendees over 7 sessions on or before the date of each session.
4. **SEMINAR:** Provide 7 one day long training sessions on Federally Chartered Corporations.

The following clauses are included in full text:

CONTRACTING OFFICER'S AUTHORITY:

The contracting officer has responsibility for ensuring the performance of all necessary actions for effective contracting; ensuring compliance with the terms of the contract and safeguarding the interests of the United State in its contractual relationships. Accordingly, the contracting officer is the only individual who has the authority to enter into, administer, or terminate this contract. In addition, **the contracting officer is the only person authorized to approve changes to any of the requirements under this contract**, and notwithstanding any provision contained elsewhere in this contract, the said authority remains solely with the contracting officer.

Contracting Officer's Representative (COR)

The contracting officer may designate in writing other government personnel, known as the COR, to act as his or her technical representative for contract administration functions which do not involve changes to the scope, performance, price, schedule, or terms and conditions of the contract. Specifically, the COR may call meetings with customers, end-users, or clients, and approve invoices. The COR may provide intermittent technical direction. Technical direction includes:

- Direction to the contractor which assists the contractor in accomplishing the statement of work.
- Comments on and approval or disapproval of reports or other deliverables.

According to FAR 1.602-2, the COR may be personally liable for unauthorized acts. The COR will be identified in the award documentation. Such designation will not contain authority to sign contractual documents, order contract changes, modify contract terms, or create any commitment or liability on the part of the Government different from that set forth in the contract.

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (NOV 2011)

“Forced or indentured child labor” means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Inverted domestic corporation”, as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under [6 U.S.C. 395\(b\)](#), *i.e.*, a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose parent corporation is incorporated in a foreign country, that meets the criteria specified in [6 U.S.C. 395\(b\)](#), applied in accordance with the rules and definitions of [6 U.S.C. 395\(c\)](#). An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at [26 U.S.C. 7874](#).

“Manufactured end product” means any end product in Federal Supply Classes (FSC) 1000-9999, except—

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or
(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act ([50 U.S.C. 1702\(b\)\(3\)](#)).

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in [38 U.S.C. 101\(2\)](#), with a disability that is service-connected, as defined in [38 U.S.C. 101\(16\)](#).

“Small business concern” means a concern, including its affiliates that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

“Veteran-owned small business concern” means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at [38 U.S.C. 101\(2\)](#)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

“Women-owned business concern” means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

“Women-owned small business concern” means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

“Women-owned small business (WOSB) concern eligible under the WOSB Program” (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

(a) The Contractor agrees to give preferences to Indians who can perform the work required regardless of age (subject to existing laws and regulations), sex, religion, or tribal affiliation for training and employment opportunities under this contract and, to the extent feasible consistent with the efficient performance of this contract, training and employment preferences and opportunities shall be provided to Indians regardless of age (subject to existing laws and regulations), sex, religion, or tribal affiliation who are not fully qualified to perform under this contract. The Contractor also agrees to give preference to Indian organizations and Indian-owned economic enterprises in the awarding of any subcontracts consistent with the efficient performance of this contract. The Contractor shall maintain such records as are necessary to indicate compliance with this paragraph.

(b) In connection with the Indian employment preference requirements of this clause, the Contractor shall also provide opportunities for training incident to such employment. Such training shall include on-the-job, classroom, or apprenticeship training which is designed to increase the vocational effectiveness of an Indian employee.

(c) If the Contractor is unable to fill its training and employment needs after giving full consideration to Indians as required by this clause, those needs may be satisfied by selection of persons other than Indians in accordance with the clause of this contract entitled "Equal Opportunity."

(d) If no Indian organizations or Indian-owned economic enterprises are available for awarding of subcontracts in connection with the work performed under this contract, the Contractor agrees to comply with the provisions of this contract involving utilization of small business concerns, small business concerns owned and controlled by socially and economically disadvantaged individuals, or labor surplus area concerns.

(e) As used in this clause:

(1) "Indian" means a person who is a member of an Indian Tribe. If the Contractor has reason to doubt that a person seeking employment preference is an Indian, the contractor shall grant the preference but shall require the individual within thirty (30) days to provide evidence from the Tribe concerned that the person is a member of that Tribe.

(2) "Indian organization" means the governing body of any Indian Tribe or entity established or recognized by such governing body in accordance with the Indian Financing Act of 1974 (88 Stat. 77; 25 U.S.C. 1451); and

(3) "Indian-owned economic enterprise" means any Indian-owned commercial, industrial, or business activity established or organized for the purpose of profit provided that such Indian ownership shall constitute not less than 51 percent of the enterprise.

(4) "Indian Tribe" means an Indian Tribe, band, nation, or other organized group or community, including any Alaska Native village or regional or village corporation as defined in or established pursuant to the Alaska Native Claims Settlement Act (85 Stat. 668; 43 U.S.C. 1601) which is recognized as eligible for the special programs and services provided by the United States to Indians because of their status as Indians.

(f) The Contractor agrees to include the provisions of the clause including this paragraph (f) in each subcontract awarded under this contract.

(g) In the event of noncompliance with this clause, the Contractor's right to proceed may be terminated in whole or in part by the Contracting Officer and the work completed in a manner determined by the Contracting Officer to be in the best interests of the Government.

INDIAN PREFERENCE PROGRAM -- DEPARTMENT OF THE INTERIOR (APR 1984)

(a) In addition to the requirements of the clause of this contract entitled "Indian Preference -- Department of the Interior," the Contractor agrees to establish and conduct an Indian preference program which will expand the opportunities for Indian organizations and Indian-owned economic enterprises to receive a preference in the awarding of subcontracts and which will expand opportunities for Indians to receive preference for training and employment in connection with the work to be performed under this contract. In this connection, the Contractor shall --

(1) Designate a liaison officer who will:

1. maintain liaison with the Government and Tribe(s) on Indian preference matters;
2. supervise compliance with the provisions of this clause; and
3. administer the Contractor's Indian preference program.

(2) Advise its recruitment sources in writing and include a statement in all advertisements for employment that Indian applicants will be given preference in employment and training incident to such employment.

(3) Not less than twenty (20) calendar days prior to commencement of work under this contract, post a written notice in the Tribal office of any reservations on which or near where the work under this contract is to be performed, which sets forth the Contractor's employment needs and related training opportunities.

The notice shall include the approximate number and types of employees needed, the approximate dates of employment; the experience or special skills required for employment, if any; training opportunities available; and all other pertinent information necessary to advise prospective employees of any other employment requirements. The Contractor shall also request the Tribe(s) on or near whose reservation(s) the work is to be performed to provide assistance to the Contractor in filling its employment needs and training opportunities. The Contracting Officer will advise the Contractor of the name, location, and phone number of the Tribal officials to contact in regard to the posting of notices and requests for Tribal assistance.

(4) Establish and conduct a subcontracting program which gives preference to Indian organizations and Indian-owned economic enterprises as subcontractors and suppliers under this contract. Consistent with the efficient performance of this contract, the Contractor shall give public notice of existing subcontracting opportunities by soliciting bids or proposals only from Indian organizations or Indian-owned economic enterprises. The Contractor shall request assistance and information on Indian firms qualified as suppliers or subcontractors from the Tribe(s) on or near whose reservation(s) the work under the contract is to be performed. The Contracting Officer will advise the Contractor of the name, location, and phone number of the Tribal officials to be contacted in regard to the request for assistance and information. Public notices and solicitations for existing subcontracting opportunities shall provide an equitable opportunity for Indian firms to submit bids or proposals by including --

1. a clear description of the supplies or services required including quantities, specifications, and delivery schedules which facilitate the participation of Indian firms;
2. a statement indicating the preference will be given to Indian organizations and Indian-owned economic enterprises in accordance with Section 7(b) of Public Law 93-638; (88 Stat. 2205; 25 U.S.C. 450e(b));
3. definitions for the terms "Indian organization" and "Indian-owned economic enterprise" as prescribed under the "Indian Preference -- Department of the Interior" clause of this contract;
4. a representation to be completed by the bidder or offeror that it is an Indian organization or

Indian-owned economic enterprise; and

(v) a closing date for receipt of bids or proposals which provides sufficient time for preparation and submission of a bid or proposal. If after soliciting bids from Indian organizations and Indian-owned economic enterprises, no responsible bid is received, the Contractor shall comply with the requirements of paragraph (d) of the "Indian Preference -- Department of the Interior" clause of this contract. If one or more responsible bids are received, award shall be made to the low responsible bidder if the bid price is determined to be reasonable. If the low responsive bid is determined to be unreasonable as to price, the Contractor shall attempt to negotiate a reasonable price and award a subcontract. If a reasonable price cannot be agreed upon, the Contractor shall comply with the requirements of paragraph (d) of the "Indian Preference -- Department of the Interior" clause of the contract.

(5) Maintain written records under this contract which indicate:

1. the names and addresses of all Indians seeking employment for each employment position available under this contract;
2. the number and types of positions filled by (A) Indians and (B) non-Indians, and the name, address and position of each Indian employed under this contract;
3. for those positions where there are both Indian and non-Indian applicants, and a non-Indian is selected for employment, the reason(s) why the Indian applicant was not selected;

4. actions taken to give preference to Indian organizations and Indian-owned economic enterprises for subcontracting opportunities which exist under this contract;
5. reasons why preference was not given to Indian firms as subcontractors or suppliers for each requirement where it was determined by the Contractor that such preference would not be consistent with the efficient performance of the contract, and
6. the names and addresses of all Indian organizations and Indian-owned economic enterprises (A) contacted, and (B) receiving subcontract awards under this contract.

(6) The Contractor shall submit to the Contracting Officer for approval a semiannual report which summarizes the Contractor's Indian preference program and indicates (i) the number and types of available positions filled and dollar amounts of all subcontracts awarded to (a) Indian organizations and Indian-owned economic enterprises and (b) all other firms.

(7) Records maintained pursuant to this clause will be kept available for review by the Government until expiration of one (1) year after final payment under this contract, or for such longer period as may be required by any other clause of this contract or by applicable law or regulation.

(b) For purpose of this clause, the following definitions of terms shall apply:

(1) The terms "Indian," "Indian Tribe," "Indian Organization, and "Indian-owned economic enterprise" are defined in the clause of this contract entitled "Indian Preference."

(2) "Indian reservation" includes Indian reservations, public domain Indian allotments, former Indian reservations on Oklahoma, and land held by incorporated Native groups, regional corporations, and village corporations under the provisions of the Alaska Native Claims Settlement Act, (85 Stat. 688; 43 U.S.C. 1601 et seq.).

(3) "On or near an Indian Reservation" means on a reservation or reservations or within that area surrounding an Indian reservation(s) where a person seeking employment could reasonably be expected to commute to and from in the course of a work day.

(c) Nothing in the requirements of this clause shall be interpreted to preclude Indian Tribes from independently developing and enforcing their own Indian preference requirements. Such requirements must not hinder the Government's right to award contracts and to administer their provisions.

(d) The Contractor agrees to include the provisions of this clause including this paragraph (d) in each subcontract awarded under this contract and to notify the Contracting Officer of such subcontracts.

(e) In the event of noncompliance with this clause, the Contractor's right to proceed may be terminated in whole or in part by the Contracting Officer and the work completed in a manner determined by the Contracting Officer to be in the best interest of the Government.

(End of clause)

Other Direct Costs and Travel

(1) Other Direct Costs--Other Direct Costs (ODCs) are items which are allowable and allocable direct costs to the purchase order for which BIA may reimburse the Contractor. Such items shall be charged in

accordance with the Contractor's established and accepted accounting practices except as stated below. The COR may provide approval for materials and supplies up to \$0.00 (for a single item or a related group of items). For costs beyond \$0.00, the BIA Contracting Officer's approval is required. For ODCs requiring the Contracting Officer's approval, Contractors shall submit ODC requests via one email to the Contracting Officer, Contract Specialist and CORs as applicable.

This consent is only intended to be a determination of technical reasonableness and is not a pre-determination as to the allowability of these costs. Equipment is considered to be "facilities" for the purpose of Part 45 of the Federal Acquisition Regulation and, with certain exceptions, may not be reimbursed as a direct charge to the contract.

(2) Travel—Travel up to \$1,000.00 for a single trip (e.g. one trip for 3 people or 1 trip for 1 person) is allowable as a charge to this purchase order with prior written consent of the COR. Travel in excess of \$1,000.00 for a single trip (e.g. one trip for 3 people or 1 trip for 1 person) is not allowable as a charge to this purchase order without prior written consent of the Contracting Officer. Except as explicitly set forth below, the Contractor shall be reimbursed for allowable and allocable travel costs actually incurred by and paid to the Contractor's employees, provided such costs do not exceed the amount that would be payable to an employee of the Department of the Interior, Bureau of Indian Affairs conducting the same travel while on Government business. In determining the dollar value of allowable Contractor employee travel costs, the limitation of the Federal Travel Regulations effective on the date of travel will apply to Contractor employees to the same extent they apply to Federal Government employees.

(a) Contractors shall submit ODC Travel Requests via one email to the Contracting Officer, Contract Specialist and CORs as applicable. Contractors shall submit the following required information per person:

(i) Purpose of travel

(ii) Mileage, including point of origin to destination locations

(iii) Hotel (#__nights) at Government rate \$__ per night

(iv) Meal per diem M&IE Government rate for _____ (\$__* __ days,
\$__* __ days)

(v) - Total

(3) The Contractor may be required to furnish to the Contracting Officer documentary proof of every travel expenditure that exceeds twenty-five dollars (\$25), including receipts for common carrier transportation expenditures. Bona fide lodging receipts may be required to be submitted by the Contractor along with the monthly invoices.

(4) The Contractor may elect to reimburse its employees for meals and incidental expenses (as defined in the Federal Travel Regulations) on a per diem basis, and the Contractor will be reimbursed for such payments. In no event shall the reimbursement allowed under this provision exceed the standard per diem rate for meals and incidental expenses allowable under the Federal Travel Regulations. (5) To the maximum extent practicable consistent with travel requirements, the Contractor agrees to use the reduced air transportation and hotel/motel rates and services provided through available Government discount air fares and lodging rates for bona fide employees' travel that is otherwise reimbursable as a

direct cost pursuant to this contract when use of such rates results in the lowest overall cost. The Contractor shall submit requests, including pertinent information, for specific authorization to use these rates to the Contracting Officer.

(a) Interest on Overdue Payment

Determination of interest due will be made in accordance with the provisions of the Prompt Payment Act.

(b) Payment due date:

(1) Unless otherwise specified in the contract, payments under this contract will be made on the 30th calendar day after the later of

- (i) The date of actual receipt of a proper invoice in the office designated to receive the invoice,
or
- (ii) The date tasks are formally accepted by the Government.

(2) If the services covered by a submitted invoice are rejected for failure to conform to the technical requirements of this contract, the provisions stated above will (i and ii) apply to the properly resubmitted document.

Invoices shall be submitted in original to the Government office designated in this contract. To constitute a proper invoice, the invoice must include the following information and/or attached documentation:

- (1) Name of the business concern, invoice number and invoice date;
- (2) Contract number, or authorization for delivery of property or performance of services;
