

ICW Reporting Form

- Guides BIA's decision making.
- ► The data collected:
 - Identifies the number of American Indian and Alaska Native children that are removed from their homes and tribal communities;
 - Helps BIA assess ICWA program effectiveness;
 - Helps BIA formulate annual budget and program justification; and
 - To monitor ICWA compliance;



What is the ICWA Report?

- Tribes or Tribal organizations receiving grants under ICWA are required to submit data on a quarterly and annual basis (25 CFR 23.47)
- Section on Tribal ICWA programs (Part A & Part B)
- Tribes that receive ICWA funding Fill out Part A Indian Child Welfare Act (ICWA) data; and
- Tribes that operate child protection programs fill out Part B Tribal Child Abuse and Neglect Data; Part B gathers data on Tribes' child protection programs.
- The Regional Social Workers and the Office of Self-Governance (OSG) are responsible for submitting the ICWA report.

Part A - ICWA



Part A - ICWA

- Required only if the Tribes/Grantees operate an ICWA program;
- Tribes are not required to complete Part A if ICWA funds are not received; and
- BIA Agencies do not operate any ICWA programs, so BIA would never complete Part A of the form.
- According to funding distribution list there are 377 ICWA Funded Tribes.

INDIAN CHILD WELFARE QUARTERLY AND ANNUAL REPORT

There are two parts to the Indian Child Welfare Quarterly and Annual Report: Part A – Indian Child Welfare Act (ICWA) Data, and Part B – Child Abuse and Neglect Data.

Part A: All Tribes/Grantees must complete Part A.

Part B: Only those Tribes/Grantees or BIA Agencies that operate a child protection program should complete Part B. If the Tribe's child protection program is carried out by the State or BIA, then Part B of this form is not required by the Tribe. If the BIA is operating the child protection program for the Tribe, the BIA Agency is responsible for submitting Part B.

Note: This report captures information about services needed and provided for Indian children and families. Indian child means any unmarried person who is under age 18 and either: (1) Is a member or citizen of an Indian Tribe; or (2) Is eligible for membership or citizenship in an Indian Tribe and is the biological child of a member/citizen

- (v) A summary of problems encountered or reasons for not meeting established objectives;
- (vi) Any deliverable or product required in the grant; and
- (vii) Additional pertinent information when appropriate.
