Other cut-off dates will be established every Friday or based upon the date that additional List of Eligibles may be requested in order to fill other vacancies. The applicants with 10-point Veterans' Preference who submit a complete application after a cut-off date but before the List of Eligibles is issued, will be considered and referred on the List, if qualified. Your applicant period of eligibility will be for six (6) months. The system automatically populates your Eligibility Begin Date when your application is rated and your Eligibility End Date is calculated on the start of the 6-month period of eligibility. You must reapply to keep your application active beyond an Eligibility End Date.</p>
