**NOTE 2:** In summary, forty-two (42) of the eighty-six (86) school locations identified in "Poor" condition are in an active facility improvement program. Thirty (30) locations are part of the Site Assessment Capital Improvement program, one (1) location is part of the Great American Outdoors Act, two (2) locations are part of the 2004 No Child Left Behind program, five (5) locations are part of the 2016 NCLB and four (4) locations are part of the Facility Replacement program.
