Title: Revised Requirements for Forest Management Plans (FMP) for Category 3 and 4 Forested Reservations

1. Purpose

The purpose of this memorandum is to revise Indian Affairs (IA) policy regarding requirements for Forest Management Plans (FMP) for Category 3 and 4 Forested Reservations. This memorandum modifies the following requirements in the Indian Affairs Manual (IAM) Part 53, issued September 1, 2006:

- Chapter 2, 2.8 FMP Content, B. Minimum Content Standards (FMP Planning)
- Chapter 8, 8.5 page 2, A. Forest Inventory for Management Planning & Trust Monitoring (Planning Inventory)
- Chapter 8, 8.6 page 5 Minimum Content Standards for a Forest Inventory Analysis (FIA)

These changes are effective immediately and will be made permanent in the Indian Affairs Manual, Part 53 Chapters 2 and 8, in the next update.

2. Scope

This policy applies to Forest Management Planning and Plan Development on Indian Forest Lands for Categories 3 & 4 Forested Reservations and may apply to Category 5 Forested Reservations.

3. Policy

The following changes are hereby made to requirements currently in 53 IAM 2 and 53 IAM 8 for Category 3 & 4 Forested Reservations, Minimum Requirements for Forest Management Plans:

- **D.** <u>Regional Directors</u> are responsible for the protection and sound management of the resources held in trust by the United States for Indian tribes. They are responsible for carrying out policy as directed, and for overseeing the implementation of policy either directly or via Agency Superintendents.
